Cancellation Policy - Boarding

Advanced notice of schedule changes and cancellations are *imperative* to accommodating clients most effectively, maintaining competitive rates, and providing high quality services at Bark Park. We greatly appreciate you understanding the need to implement the following cancellation policies and associated fees.

*Advance notice is based on the original scheduled drop off time

Standard Period (Non-Holiday) Cancellations

72+ hours advance notice of cancellation – No Extra Fee

Less than 72 hours advance of cancellation – 50% of total balance due for scheduled reservation

Less than 24 hours or No-Show – 100% of total balance due for scheduled reservation

Holiday/Priority Period Cancellations

Applies to reservations with at least 1 full day within the Holiday/Priority Period.

2023 Effective Dates:

April 3rd – April 17th

May 22nd – September 10th

November 16th – November 28th

December 18th – January 2nd

With 7+ days advance notice of cancellation – No Extra Fee

Less than 7 days advance notice of cancellation – 50% of total balance due for scheduled reservation

Less than 72 hours advance notice of cancellation – 100% of balance due for scheduled reservation

*Cancellation fees must be paid before check-in for the next scheduled service.

Cancellation Policy - Daycare

We ask that all pet parents give at least 1 day notice of cancellation.

A Full Day of Daycare (\$24) will be charged to the card on file for all Same-Day Cancellations and No Call No Shows.

The \$24 cancellation fee is regardless of half day or full day reservation.

In order to enforce our Daycare Cancellation Policy, a credit card will be placed on file in our system. If a card is not currently on file with us, the cancellation charge will be placed on pet owners account to be settled upon their next visit.

*Cancellation notice may be given via email (rusty@barkparkmt.com) or by calling our front desk (406-894-2275) and leaving a voicemail with pet owners name, dog's name, date of cancellation, and any other information that may be relevant.



Dog Daycare & Dog Boarding Policies and Release of Liability

THIS AGREEMENT is entered into by and between Bark Park, LLC, and dog owner

Dog(s) name / breed(s) _____

- 1) I (Owner) represent that I am the legal owner of the above named dog(s) and I assume all risks, dangers, and responsibilities for injuries to the named dog(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's dog(s) is/are attending daycare/boarding.
- 2) **SPAY/NEUTER: All dogs over 6 months of age must be spayed or neutered to attend Daycare or Boarding.**
_____ (initial) I confirm and can provide documentation that my pet is spayed/neutered.
- 3) **PHOTO & VIDEO RELEASE:** We love to post pictures and videos on Social Media, our website, and/or in magazine ads. Owner agrees to allow Bark Park to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at Bark Park, in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and Owner releases to Bark Park all rights that Owner may possess or claim to such image, likeness, recording, etc.
- 4) **DOG'S HEALTH/VACCINATIONS:** Owner understands and agrees that Owner's dog(s) are healthy and will at all times while attending Bark Park have current vaccinations for rabies, distemper, and Bordetella. Owner is not enrolling any dog that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. **Owner further understands that even if Owner's dog(s) is/are vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog(s) can still contract Kennel Cough.** Owner agrees that Owner will not hold Bark Park responsible if Owner's dog(s) contracts Kennel Cough or other dog-dog transmitted ailments.
- 5) **FLEA/TICK FREE:** All dogs must be flea/tick free. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner of up to \$80 depending on severity and size of dog.
- 6) **GROUP PLAY/BEHAVIOR:** All dogs must pass a general behavior evaluation in order to attend dog-dog group play. No dog may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting their dog(s) to group play, Owner is representing to Bark Park that their dog(s) have not harmed, shown aggression or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Bark Park staff may be required to leave daycare/boarding immediately.
- 7) **RELEASE OF LIABILITY:** Owner understands and agrees that during normal dog play, Owner's dog(s) may sustain injuries. Dog play is monitored by Bark Park staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither daycare/boarding nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases Bark Park LLC staff or volunteers of any liability of any kind whatsoever arising from or as result of Owner's dog(s) attending Bark Park.
- 8) **PERSONAL PROPERTY:** Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees or invitees of Bark Park, or to the equipment, facilities, or other property of Bark Park LLC, caused by Owner's dog(s). Total cost of damage will be applied to the invoice at checkout.

- 9) **FOOD/MEDS:** When boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog is cared for by Bark Park. Should the food/medication supply need replacement, Owner authorizes Bark Park to purchase replacement and Owner will reimburse Bark Park for the actual food and medication costs plus up to \$25.00 time/distance trip fee (per occurrence).
- 10) **VETERINARIAN LIABILITY AND CARE:** Owner agrees that Bark Park may obtain medical treatment for Owner's dog(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that dog(s) may need medical treatment including anesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purpose of such treatment. Owner gives permission to Bark Park to use Owner's vet or nearest 24-hour vet hospital for required treatment. **Yes _____ or No _____** (initial)
- 11) **WEAKENED IMMUNE SYSTEM:** Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding the Owner is waiving any claim for injury or illness experienced by Owner's dog(s) while in our care.
- 12) **ELDERLY DOGS:** Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to contact Owner immediately and transport Owner's dog to Owner's vet (within 15 miles) where he/she will be held until Owner can be reached by the Vet for further instructions. If the Owners vet is closed or outside of our transport distance, then we will transport to the nearest 24-hour facility. Trip charge will apply based on time/distance.
- 13) **GROOMING** expense to be paid if Owner's dog(s) nails are too long and causing breaking of skin or deep scratches to staff, volunteers, and/or other dogs. Nail trim fee is \$10.00. In addition, if Owner's dog(s) happens to soil their fur during their visit, we will bathe them at Owner's expense.
- 14) **PREPAID PACKAGES:** Owner understands that prepaid daycare packages are nonrefundable and expire 3 months from date of purchase. Daycare Packages must be paid for prior to the pet being checked in.
- 15) **PAYMENTS** are due and payable at the end of each visit. Payment may be made in American currency, Visa, Discover, or Mastercard. \$25 NSF charge for returned checks. We do not accept Canadian credit cards.
- 16) **CANCELLATION / NO-SHOW POLICY:** (see Boarding Cancellation Policy)
- 17) **CLOSING TIME/LATE PICKUP FEE:** **Owner agrees that if Owner's dog(s) is/are not picked up by closing time, the Owner will be charged a late fee of \$25 per dog in addition to their total for services that day. If the Owner does not pick up their dog(s) before Bark Park LLC staff lock the doors and leave the property, the Owner hereby authorizes overnight boarding appropriate for dog(s) and to pay Bark Park for applicable overnight boarding charge per dog and pay any charge for required food.**
- 18) **RIGHT OF REFUSAL:** Bark Park reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of Bark Park LLC.
- 19) **FULL FORCE AND EFFECT:** Owner further understands and expressly agrees that each and every of the foregoing provisions contained in paragraphs 1-18 shall be in full force and effect and shall apply to each and every occasion on which Owner's dog(s) stays with Bark Park for daycare, extended boarding, or other services, as the case may be. This agreement shall remain in full force and effect as between the parties until and unless otherwise canceled or superseded by a writing signed by the parties.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
